Topic 2: Policy on cash deposit into the association's bank account

Currently, BPI has \$640 in cash on hand (including \$200 of Annual Membership Fee & Donation from THI MONG THINH HO on 13th July 2025).

According to the BPI constitution, two committee members must be present when depositing cash into the association's bank account. In addition, the bank charges a \$3 fee per deposit.

To save on labor and bank fees, Yuping HE has called for a vote on a policy regarding cash deposits into the association's bank account.

Vote on this policy:

Cash to be deposited into the association's account only if cash on hand is AUD 1,000 or more.
