2. Chairperson's Message

It is my great honor to present the Annual Report for Buddhas' Practice Incorporated for the financial year 2023-2024. This year has been marked by significant growth, deepened understanding, and strengthened community bonds.

Throughout the year, we have witnessed remarkable dedication from our members, preachers, and volunteers. Our organization has grown from 74 to 87 members, with 67 actively participating in our Annual General Meeting. This growth reflects the increasing interest in Buddhist teachings and the value our community finds in our programs.

Under the guidance of our esteemed Advisor Bennie Spirit, we have conducted numerous activities including daily online worship, weekly Dharma talks, monthly committee meetings, and special celebrations. Our Buddhist Teaching and Research Center (BTRC) has successfully conducted four thesis defense debates, demonstrating the depth of scholarly pursuit within our organization.

Our office in Parap has been open 306 days this year, providing a welcoming space for meditation, study, and spiritual guidance. We have also strengthened our multilingual outreach, with dedicated preachers serving Chinese, Vietnamese, and Japanese-speaking communities.

Looking ahead, we remain committed to expanding our reach, deepening our practice, and serving the community with compassion and wisdom. I extend my heartfelt gratitude to all our members, volunteers, and supporters who have made this year possible.

3. Membership Report

3.1 Membership Overview

As of 30 June 2024, BPI has a total of 87 registered members, representing growth from 74 members in the previous financial year. This 17.6% increase demonstrates the growing appeal of our organization and its teachings.

The Annual General Meeting held on 19 October 2024 via Zoom achieved a 77% attendance rate, demonstrating strong member engagement.

3.3 New Members

During the 2023-2024 financial year, BPI welcomed 13 new members while 2 members ceased their membership, resulting in a net growth of 11 members.

4. Committee Reports

4.1 Buddhist Teaching and Research Center (BTRC)

Director: Huaigu WANG

4.1.1 Thesis Defense Work

The BTRC held four thesis defense debates during the financial year. Four Dharma preachers successfully completed and defended their theses on the following topics:

- On the relationship between doubt and disease
- On the relationship between arrogance and disease
- On the relationship between greed and disease
- On the relationship between hatred and disease

All participating preachers — Guiling SUN, Meiling CHEN, Shan YAN, and Zhifang LIU — successfully passed their respective thesis defenses.

4.1.2 Essay Writing Seminar

Huaigu WANG presided over four sessions of the essay writing seminar. Five Dharma preachers actively participated, enhancing the ease, fluency, and quality of their writing through presentation, study, and discussion of theses.

4.1.3 Dharma Lectures

BTRC preachers have consistently delivered lectures throughout the year, promoting Buddhist teachings. The following table summarizes the lecture activities:

4.2 Vice-Chairperson's Report - Acts Learning Program

Vice-Chairperson: Jing DONG

The ACNC Act Learning program has been a cornerstone of our educational initiatives this year. Classes were conducted daily from Monday to Sunday, 6:30-7:30 PM Beijing Time (8:00-9:00 PM Darwin Time).

Key Achievements:

- Developed basic understanding of the ACNC Association Act's framework
- Gained familiarity with Act-related vocabulary
- Improved fluency in reading and reciting the Act
- Enhanced English proficiency among Chinese-speaking members

The program has employed various teaching methods including repetitive playback, shadowing, recitation, keyword analysis, and interactive discussions to maximize learning effectiveness.

4.3 Chinese Preacher's Report - Meditation Center Preparation

Chinese Preacher: Chengli LI

The preparation of the Meditation Center at 35 Brooking Circuit, Virginia, was a major project undertaken this year. The primary aim was to provide a dedicated space for meditation practice, along with access to relevant meditation books and on-site guidance.

Major Accomplishments:

- Completed housing construction (August 2023 - January 2024)
- Successfully installed Buddha statue (May-July 2024)
- Compiled meditation-related books based on Buddhist scriptures
- Decorated Buddhist Hall (July 2024)

Although government approval for community use was not obtained due to zoning restrictions, Chengli LI continued to dedicate herself to writing meditation books, including 'Wonderful Wisdom of Observation' and 'Summary of Meditation and Samadhi', both currently being compiled and translated.

4.4 Vietnamese Preacher's Report

Vietnamese Preacher: Thimytrang LE (Grace)

Key Activities:

- Organized 3rd Anniversary Celebration (November 19, 2024) with 40 attendees
- Hosted Vietnamese Lunar New Year Celebration (February 10-11, 2024) with 18 participants
- Conducted 172 Buddhist worship sessions and receiving believers for practice
- Delivered multiple Dharma talks on various sutras including Medicine Buddha Sutra and Ksitigarbha Sutra

The Vietnamese community has shown genuine interest in Buddhist practice, with many members developing joy and aspiration to apply principles in their daily lives.

4.5 Secretary & Web Manager's Report

Secretary & Web Content Manager: Yinfeng WANG

The Secretary has fulfilled all duties in accordance with the NT2003 Act, including coordination of correspondence, recording and archiving meeting minutes, maintaining the Register of Members, and managing key documents.

Meeting Statistics:

- Total meetings held: 18 (17 Committee Meetings + 1 AGM)
- All minutes properly recorded and archived
- Member register maintained and updated

The website has been enhanced this year, becoming a platform for authentic Buddhist teachings. Special recognition goes to Yuping HE and Zhaohe YANG for their contributions to web content management, which attracted esteemed authors Dr. Mr. Bodhi and Dr. Mrs. Bodhi to publish their works on our platform.

Community Building: Foster a welcoming environment that encourages new members while supporting the spiritual growth of existing members.

Digital Presence: Enhance our website and online platforms to reach a wider audience and provide accessible Buddhist teachings.

Financial Sustainability: Seek government grants and diversify funding sources to ensure long-term organizational stability.

7.3 Challenges and Opportunities

While we celebrate our achievements, we acknowledge the challenges ahead. The organization currently faces a shortage of personnel for key positions and maintains a modest financial surplus. However, these challenges present opportunities for growth and community engagement.

With the continued guidance of our Advisor Bennie Spirit and the dedication of our committee, preachers, and members, we are confident in our ability to overcome these challenges and continue serving the community with wisdom and compassion.
