Buddhas' Practice Incorporated (BPI) is pleased to present its Annual Report for the financial year 2024-2025. This report highlights the association's achievements, financial performance, and strategic direction as we continue our mission to advance Buddhism through education, community engagement, and compassionate service.

Year in Review

The 2024-2025 financial year has been marked by significant growth and deepening community engagement. Despite financial challenges, BPI has maintained its commitment to providing high-quality Buddhist teachings and expanding our reach across diverse communities.

Mission and Purpose

BPI is dedicated to advancing Buddhism by providing Buddhist teachings, leading Buddhist worship and religious activities, and undertaking activities consistent with promoting and practicing the Buddhist religion.

The association is governed by a dedicated committee of 12 members, supported by our Advisor and numerous volunteers. The Annual General Meeting was held on November 8, 2025, with 80 out of 104 members in attendance (77% participation rate).

Departmental Reports

Buddhist Teaching and Research Center (BTRC)

Under the leadership of Director Huaigu WANG, the BTRC continued to excel in advancing Buddhist scholarship and practice. The center focused on three main areas of activity:

Thesis Defenses

Four Dharma Preachers successfully completed and defended their theses on critical Buddhist topics:

- Rev. Yinzheng (Guiling SUN) - On the relationship between ignorance and disease
- Rev. Yinfan (Meiling CHEN) - The inevitable relationship between the ten good deeds and spiritual achievements
- Rev. Fafu (Shan YAN) - Self-nature is not words or language, how can it be expressed in words or language?
- Rev. Yinyi (Zhifang LIU) - On precepts

Essay Writing Seminars

Four essay writing conferences were organized, with five Dharma Preachers participating actively. These seminars successfully enhanced participants' writing fluency, quality, and confidence in expressing Buddhist concepts.

Dharma Lectures and Video Production

BTRC preachers delivered over 2,000 hours of Buddhist teachings throughout the year, demonstrating exceptional dedication to promoting the Buddha's teachings. The following table summarizes the teaching activities:

BPI Chinese Preacher Report

Rev. Yinyue (Chengli LI) conducted 14 comprehensive courses totaling 371 hours of teaching throughout the year. Her work emphasized progressive learning within the Mahayana framework, guiding members from generating Bodhicitta to cultivating wisdom and compassion.

Notable Achievements

- Completed 370 teaching sessions covering 14 distinct courses
- Continued compilation of the Mahayana Practice System Process series
- Produced vernacular versions of sutras for beginner practitioners
- Developed comprehensive study materials on Generating Bodhicitta

Vietnamese Preacher Report

Rev. Grace (Thimytrang LE) led the Darwin office operations and Vietnamese community outreach, achieving remarkable engagement with 447 visitor interactions throughout the year.

- 5th Anniversary Celebration (November 24, 2024) - 24 participants
- Lunar New Year Celebration 2025 (January 26, 2025) - 25 participants
- 447 visitor engagements for Dharma study and guidance
- 7 new disciples took refuge with the Triple Jewel
- 9 new members joined BPI

Vision for 2025-2026

Rev. Grace outlined an ambitious plan centered on implementing the Great Compassion Dharma Gate through VITACHOICE, focusing on removing suffering and bestowing joy to all sentient beings through wisdom-based, scientific approaches.

Administrative Reports

Secretary & Web Manager's Report

Yinfeng WANG reported successful completion of all secretarial duties in accordance with the Associations Act (NT 2003). Key achievements included:

- 13 meetings conducted (12 Committee Meetings + 1 AGM)
- All meeting minutes completed and archived in compliance with legislation
- Member register maintained in accordance with statutory requirements
- IT Skill Sharing Session conducted on September 8, 2024
- Website maintenance and content management support

Vice-Chairperson's Report

Jing DONG focused on ACNC compliance training and expressed commitment to increased contribution in the coming year. She encouraged members to share learning interests and preferred formats for future training activities.

Financial Report

The following financial summary reflects BPI's operations for the financial year ended June 30, 2025. While the association recorded a deficit for the year, our strong cash position and disciplined expense management provide a solid foundation for future growth.

Financial Analysis

Key Observations

- Strong Cash Reserves: Despite the deficit, BPI maintains robust cash reserves exceeding \$251,000
- Improved Interest Income: Term deposits generated \$7,319.04 compared to only \$94.52 in the previous year
- Membership Growth: Membership income doubled from \$1,296 to \$2,592, reflecting community expansion
- Reduced Donations: Primary cause of deficit - donations decreased from \$70,743.54 to \$46,367.78
- AASB 16 Compliance: Successfully implemented lease accounting standards

Compliance Matters

The annual audit was completed with an unqualified opinion. All financial reporting requirements under the Associations Act have been met. The association's Income Tax exemption has been active since May 27, 2022.

Programs and Activities

Regular Programs

- On-site office operations: 11 AM to 8 PM daily (365 days)
- Online worship sessions: Twice daily (730 sessions annually)
- Online Dharma speeches in audio format: Daily by Rev. Fashan (365 sessions)
- BTRC preacher lectures: Delivered by 8 preachers covering various sutras
- Dr. Bodhi's Essential Fundamentals lectures: 67 recorded sessions
- General Psychology Studies by Dr. Rose: 12 recorded sessions
- Delusive Thinking lectures by Yuping HE: 171 sessions

Weekly Activities

BPI Advisor Bennie SPIRIT delivered 52 Dharma talks throughout the year, responding to local members and visitors' requests for spiritual guidance.

Monthly Activities

Committee members convened 12 monthly video conferences to discuss organizational matters and review financial statements.

Four thesis defense sessions and four essay writing seminars were conducted by the Buddhist Teaching Research Center throughout the year.

Strategic Priorities for 2025-2026

BPI's strategic focus for the coming year centers on deepening Buddhist study, expanding community engagement, and implementing practical compassion through innovative approaches.

Priority Goal 1: Shurangama Sutra Study

Intensive study of the Shurangama Sutra with the aspiration to achieve Shurangama Samadhi. This comprehensive study will form the foundation for advanced practice and understanding.

Priority Goal 2: Understanding Afflictions

Deep exploration of mental afflictions through texts such as The Treatise on the Hundred Dharmas, maintaining pace with contemporary Buddhist teachings and practical applications.

Priority Goal 3: Cultivation Route for Great Bodhisattvas

Comprehensive understanding of the path of Great Bodhisattvas, with particular emphasis on cultivating Great Compassion as the essential foundation for Buddhist practice.

VITACHOICE Initiative

On September 15, 2025, BPI founded VITACHOICE LTD as a practical manifestation of Great Compassion. This initiative represents our commitment to applying Buddhist wisdom to contemporary challenges, particularly in the areas of physical and mental well-being.

VITACHOICE Mission

VITACHOICE operates on three core principles:

- For charity only, not for profit
- Based on science and Right View
- Departing from suffering through wisdom

The Six Perfections Framework

VITACHOICE operations follow the Six Perfections (Pāramitās) framework:

- Generosity: Sharing Dharma and science-based knowledge freely
- Precepts: Avoiding profit-driven motives, upholding compassion with integrity
- Endurance: Responding to challenges with gentleness
- Diligence: Unwavering effort in propagating the Great Compassion Dharma Gate
- Concentration: Abiding in clarity and non-attachment

- Wisdom: Applying scientific Right View to eliminate ignorance and transform habits

Challenges and Opportunities

Current Challenges

- Talent Development: Need for more trained volunteers and leaders
- Funding Sustainability: Addressing the decline in donation income
- Western Community Engagement: Limited impact on local Western communities

Strategic Responses

- Increased commitment and daily dedication from existing members
- Diversified income through term deposits and exploring government grants
- Cultural adaptation and deeper integration into Western society
- Committee vacancy recruitment drive with three-month orientation period

BPI is actively recruiting for key committee positions including Chairperson, Treasurer, and Vice Chairperson.
