Overview and Objective The primary goal of this plan is to professionalize BPI's workforce—including both staff and volunteers—by aligning spiritual scriptural mastery with Australian legal standards and public health needs. The approach ensures BPI remains spiritually authentic while staying operationally professional within the regulatory landscape.</p> <p>2. The Four Critical Pillars of Training</p> <p>Pillar 1: Dharma Leadership &amp; Pedagogy: Focused on training preachers and study group leaders to effectively teach Dharma in a modern context through scriptural analysis, public speaking, and adult learning techniques.</p> <p>Pillar 2: Governance &amp; Compliance: Aimed at ensuring BPI remains a "Charity in Good Standing" by training committee members on the Associations Act 2003 (NT), ACNC Governance Standards, and financial stewardship.</p> <p>Pillar 3: Compassion in Action (Health &amp; Diabetes Awareness): Merges Buddhist "Great Compassion" with science to address the Type 2 Diabetes crisis through lifestyle management and "Right View" training.</p>
